
Dear Madam and Sirs,

I write in connection with counsel for the Claimant's letter of February 2, 2005, requesting an extension for the filing of its Memorial on the Merits in the above case and the United Mexican States' letter of February 3, 2005, indicating that the Respondent would not oppose to such request.

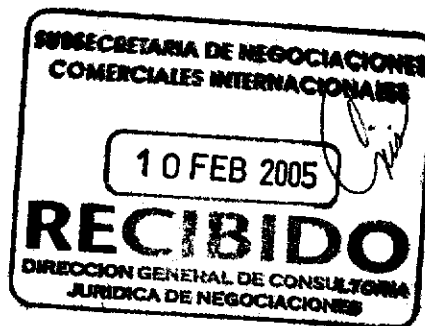
- The Respondent should file its Counter-Memorial on the Merits no later than August 15, 2005;
